ROOMS CONTRACT TERMS

DOYLESTOWN QUARTER MIDGETS 8/29/08

1. All food and beverages served or consumed in guestrooms, suites, functions or banquet room/s that are used for hospitality or entertainment shall be purchased from Holiday Inn Morgantown.
2. If guestrooms are used for hospitality or entertainment, the number of guests attending such functions shall be approved by the Holiday Inn Morgantown management unless, in the room/s being so used, the group is limited to persons occupying such room/s or overnight accommodations.
3. Persons or guests arranging for meeting or banquet facilities at Holiday Inn Morgantown, which will be used for functions where alcoholic beverages are to be served or consumed, agree to conform to any restrictions, which are, or may be, imposed by the Liquor Control Board, insofar as they affect the premises of the Inn.
4. Group must conform to all Local, State and Federal regulations; this includes consumption of alcohol by minors. No large quantities of alcohol permitted in hotel rooms.
5. Holiday Inn Morgantown also reserves the right, in deference to it's guest and patrons and for the proper management of the Inn, to limit the products, wares, musical instruments, etc. selected to be shown or demonstrated in it's facilities. It is required that the general nature of all products to be shown or demonstrations be made known, in advance, to only repayment or deposit.
